- TrueCommerce's e-invoicing service removes the need for you to scan or key invoices in to your accounts payable application, improving accuracy and reducing the time and costs associated with invoice processing.
- A sophisticated rules engine validates invoices based on your preferences, including validation against the purchase order, shipment, and receipt, helping to improve invoice match rates and reduce the time required to clear invoices for payment, allowing decisions to be made on whether or not to take discounts for early settlement.
- Electronic invoicing legislative and tax requirements are supported for 40+ countries.

HOW DOES IT WORK?

The TrueCommerce e-invoicing service replaces paper invoices with electronic equivalents that are mapped into your accounts payable application.

Your suppliers can send invoices to the TrueCommerce service in one of three ways:

- 1 By sending electronic invoices directly from their accounts payable application.
- By sending a PDF version of the invoice as an attachment to an email.
- By using the TrueCommerce OneTime™ portal to key an invoice, or to convert an order, shipment, or receipt in to an invoice.

This flexibility allows you to include all suppliers in your e-invoicing initiative, whatever their size or IT sophistication. Regardless of the method used to create or send invoices, the TrueCommerce service validates and converts all invoices to a format that you can easily import in to your accounts payable application.

The OneTime[™] portal also provides suppliers with information regarding the status of their invoices, helping to reduce the number of invoice queries your teams receive.
