Role advertised: Head of Healthcare and Innovation – GS1 Ireland (Role Code 202503)

Contract Type: Full-time Location: Dublin

**Purpose of the Role:** To lead the adoption of GS1 Identification and Traceability Standards across Ireland's healthcare sector, maintain GS1 Ireland as the trusted standards partner for Digital Transformation and continue to grow the membership, solutions and services for healthcare.

**Role Summary:** The Head of Healthcare and Innovation will join GS1 Ireland's Senior Leadership Team, reporting to the Chief Executive Officer and lead the Healthcare Team to implement GS1 Ireland's Healthcare Strategy.

We are looking for a highly motivated, results driven and strategic-thinking individual to build on GS1 Ireland's work to date to drive the adoption and use of GS1 Standards across the wider healthcare sector from manufacturers of pharmaceuticals and medical devices to distributors, healthcare providers and other industry partners.

This is an exciting opportunity given the investments currently being made in digitising healthcare nationally and the role that GS1 standards are playing in supporting regulatory compliance and making care safer and more efficient in Ireland and globally.

#### **Key Responsibilities:**

- Strategic approach: Define and execute the vision and strategy for GS1 Ireland Healthcare, ensuring alignment with GS1 Ireland's overall Strategic Plan. Focus on driving membership growth and delivering value to members through the adoption and implementation of GS1 standards-based services and solutions.
- Operations Management: Oversight of budget and revenue from GS1 Ireland's healthcare solutions and services, ensuring optimisation of resources and achievement of best-in-class service delivery
- **Team leadership:** Build, manage and mentor the healthcare team to deliver growth in membership, services and solutions including identification of new opportunities for services to members in coordination with other GS1 Ireland team members
- Stakeholder engagement: Lead the Senior engagement with the HSE across relevant programmes such as Health Identifiers and Scan4Safety to ensure the adoption of the GS1 standards are understood and included in digital health solution design and implementation in the HSE's "Digital for Care" programmes
- **Member support:** Oversight of all healthcare and innovation related member enquiries including training programmes for members and stakeholders as required

- Community engagement: Facilitate the GS1 Ireland Scan4Safety Working Group as a platform for healthcare professionals implementing Scan4Safety to collaborate and provide guidance and expertise, thus ensuring GS1 Standards are adopted correctly across the sector
- Build awareness: Develop and maintain relationships with senior leaders including senior policymakers, healthcare professionals, and healthcare industry leaders e.g., pharma and medical device suppliers and other associations to strengthen awareness, visibility and support for GS1 standards
- Marketing: Work closely with the GS1 Ireland Marketing Team to develop and execute a
  healthcare content strategy to include best practice sharing across all our channels to raise
  the profile, relevance and understanding of GS1 Ireland for members, solution providers and
  key stakeholders
- **Solution Provider Programme**: Responsible for the growth of the GS1 Ireland Solution Provider Programme for healthcare to ensure solution providers are GS1-compliant
- Events: Represent GS1 Ireland at industry events and national healthcare conferences, and actively seek opportunities to speak, or chair, as appropriate

# **Qualification and Experience:**

- **Education**: A Bachelor's degree in Business, Healthcare, or a related field is required. A postgraduate or Master's qualification and/or clinical background is highly desirable.
- **Professional Experience**: Minimum of 10 years of demonstrated leadership experience within the healthcare sector, with a track record of working collaboratively with key stakeholders. Experience should include the successful implementation of Digital Health solutions, particularly those leveraging standards-based approaches.
- **Industry Knowledge**: In-depth understanding of healthcare systems and operations, with knowledge of standards-based, best-practice traceability and data solutions within the health sector.

This system allows hospitals to track items from the supplier to the patient, providing real-time visibility and enabling better inventory management and decision-making.
