Ideally, samples should be in their final form, which allows for more extensive testing in terms of colour, contrast, location, etc. Note that reports of tests done on loose labels or unfilled packaging may not be reliable since applying labels or filling packages can sometimes affect the scanning performance of a barcode due to the shape of the unit or the effects of filling-colour showing through, package bulging, etc

Retail units that are curved, bottles, cylinders, etc. should be submitted with attached and loose labels where possible. Please note, traded units, cartons, inner packaging, etc. can be sent flat to enable ease of postage. Please note, a physical copy of the verification application form should accompany physical samples, while a verification application form should be 'attached' to any artwork being sent electronically.

Quality may vary between print runs so it is recommended that you have your barcodes verified on a regular basis. We recommend that you send your barcodes in for verification every time you do a new print run.
